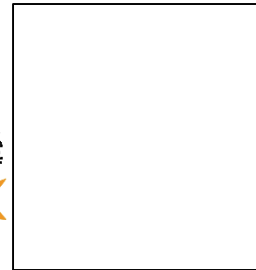

Approved TVET Fees Structure Per Module

Formal admission into mainstream TVET programmes shall commence at Level 4 and above for Certificate and Diploma programmes. All programmes below Level 4 shall be categorized and administered as short courses, separate from the mainstream qualification pathways. Mbeere North Technical and Vocational College ensures appropriate structuring and certification of such short courses in line with the relevant regulatory frameworks. Each level has different number of modules.

RULES AND REGULATIONS FOR TRAINEES

GENERAL

These rules and regulations are applicable to all trainees in Mbeere North Technical and Vocational College (MNTVC) whether on regular programs or on short courses.

The College expects the trainees to work diligently to develop to the full of their sense of loyalty, responsibility and honesty. They are also required to work hard to achieve high standards of academic performance.

The trainees are expected to comply with them in a mature and understanding way in order to line up to the College motto “**SKILLS DEVELOPMENT FOR INDUSRY**” Appropriate disciplinary action will be taken against any trainee failing to comply with them.

RULES & REGULATIONS FOR TRAINEES

Reason for having the rules and regulations:

In any community that is living together and sharing common facilities and aspirations, it is necessary to establish a code of conduct and ethics that will enable its individuals to enjoy their rights and privileges, MNTVC is a community consisting of adult trainees who are expected to observe, among others, the following rules and regulations in an effort to shape them and have a high standard of living as a community. As part of this community you are specifically required to help care for the college equipment and facilities and set a high standard of moral behavior, cleanliness, diligence and orderliness.

SPECIFIC RULES & REGULATIONS

1.Smoking

Smoking is not permitted within the college.

2.Use of narcotics or illegal drugs

Processing, handling or consumption of narcotics or illegal drugs is criminal offence (Punishable by law)

3.Alcoholic beverages

Consumption or processing of alcoholic beverages within the college is not allowed. Trainees found under influence of alcohol to an extent where their behavior is influenced by it will be disciplined.

4.Attendance of classes

Attendance of classes and other scheduled tuition activities is **COMPULSORY**.

Punctuality is essential. Leave of absence should be filled if a trainee has to be away from college when scheduled for lessons.

5. Assault

Assault is a criminal offence and it is strictly forbidden to fight within the college.

6. Bullying

Any form of bullying such as physical, social, verbal, racial, religious, sexual, disability and cyber bullying are prohibited within the college.

7. Accommodation (rented)

It is the responsibility of the trainee to take care of the room and the facilities therein.

8. Attendance of assemblies and other meetings

Attendance of all official assemblies and meetings is compulsory

9. Dressing

Trainees are expected to dress neatly, smart and decent at all times. Trainees should be in Official wear during official College functions.

10. Illness

Emergency Cases of illness while within the college must be reported to the dean immediately. The college will do first aid then communicate to guardian for follow up.

11. Channel of communication

Correspondence with other institutions or corporations from the trainees' council Or clubs MUST be submitted through the Dean of Students who will in turn communicate through the principal. College headed paper should NOT be used for private correspondences.

12. Freedom of worship

The college is non-denominational. Each student is free to practice his/her faith but should be aware of rights of others to do so. Religious groups wishing to utilize college facilities must obtain right of entry from the Dean of Students.

13. Personal security

All trainees will be provided with a college identity card. The cost for replacement of lost or damaged trainee's identity card will be met by the trainee

All trainees are strongly advised to carry their trainee identity cards whenever they are within and outside the college. While the college will make all attempts to provide security, the colleges will not be held responsible for loss of personal belongings. All trainees should be familiar with the use of fire extinguishers and other safety measures

available in the college. (Dean of trainees to ensure demonstrations are done on their use by authorized officers)

14. Warnings

Throughout the duration of your stay in the college, you will be expected to take your studies seriously and maintain a good academic performance. Breaking of college rules and regulations and other misbehavior, may lead to a verbal or written warning. In cases where a student repeatedly breaks the rules and regulations, the Principal/Secretary Governing Council has the authority to suspend such a trainee from college with immediate effect. The Ministry of Education has authority to expel a student from college.

15. Reports

Any incident or major problem should be reported immediately to the Security Dean of trainees, trainer on duty or Deputy Principals.

16. Punctuality

Trainees are expected to be punctual at all times. This sense of punctuality will be a preparation for future responsibilities and also assist in the smooth running of everyday activities in the Institute.

17 Flag Hoisting

Flag hoisting days are Mondays and Fridays at 7.45a.m. This will be done by Scouts /Rovers.

18 Class Meetings

Trainees will have class meetings with class lecturers at least once a week (minimal) to pass important messages and announcements.

19 Language

English and Kiswahili are the official languages of the college. Use of indecent language shall not be condoned at any one time. Any trainee found with the offence will be liable for suspension for a week.

20. Co-Curricular activities

Trainees are advised to join at least one club or society of the institute.

21. Exams

All trainees should sit and pass continuous Assessment Tests, End of Term and End of course Examination. Trainees who gets refers in any subject shall sit for Supplementary exams.

22. **Pregnancy** is discouraged during training.

23. **Gross Misconduct:** This entails

- a) Fighting
- b) Stealing (being in possession of stolen items)
- c) Alcohol/drug abuse
- d) Disobedience
- e) Abortion
- f) Shy-locking
- g) Being in possession of any pornography material
- h) Malicious damage to property.

Punishment includes:

Suspension for two weeks and/or appearing before the Board of Governors for further disciplinary action.

In summary trainees should be self-disciplined and exhibit serious involvement in curricular activities, ensure co-operation, self-respect and respect for others and their property for smooth running of the college. Please create an atmosphere conducive for successful training in MNTVC.
